3. I have received and read a copy of the operational rules and understand that it is my responsibility to ask questions about the operational rules and regulations if necessary. I understand that it is my responsibility to ensure that I/my children understand the rules. Although there are referees to monitor children/adults playing, it is my responsibility to monitor my children and my own activities. I will bring any observation of the rules being broken to the attention of a Monkey Joe's staff member. I certify that I and/or my child are in good health and that I and/or my child have no physical limitations which would preclude safe participation at Monkey Joe's.

In consideration for the admission of my child, I hereby release, waive and forever discharge and covenant not to sue **Bahiazul Enterprises, LLC**, and it's owners, employees, officers, directors, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damages, liability, cost or expense including attorneys fees which are related to or arise out of or in any way connected to my child's participation or use of the facility.
5. By the execution of this agreement, it is my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against **Bahiazul Enterprises, LLC**, its owners, agents, employees, officers, directors and/or all other persons or entities acting on its behalf.
